I, herein referred to as "the model", understand and acknowledge that the, photographer(s) or videographer(s) collectively referred to as "The Photographer", is creating art and/or digital content in the form of photographs, illustrations and/or video on the date of this signing, under the title and/or description listed above, which contains my likeness, voice, performance and/or property which shall be referred to collectively as "My Image";

* I specifically acknowledge that the nature of the content may include images and depictions of body parts (such as legs and feet) and situations that are artistically fetishized. Unless specifically excluded below, I agree to appear in such images.

I hereby grant The Photographer the unrestricted right to capture My Image using any technology for recording including but not limited to, digital camera, film camera, video camera, cell phone camera, sports action camera, audio recording devices, or any technologies in existence now, or in the future invented;

For good and valuable consideration, the receipt of which is hereby acknowledged, I absolutely and irrevocably authorize, The Photographer, successors, and assigns the right to use and reuse My Image in publication and distribution, in whole or in part, in digital, print, online or any media now or in the future invented, and any other lawful use as may be determined by The Photographer, in their sole and exclusive discretion throughout the world, for commercial or non-commercial purposes, without restriction (to the extent permitted by law). For the avoidance of doubt, The Photographer may make My Image available for resale to third parties for the reproduction and/or distribution by that third party in any medium throughout the world;

I acknowledge that My Image may be edited, stored, copied, and reused at the sole discretion of The Photographer and that My Attributes may be blurred or distorted or altered in any manner and I waive any right to inspect or approve the intermediary product or the finished product;

I hereby release The Photographer, successors, licensees, assigns, and associates from any damages or claim by me or anyone else arising out of the capturing or of the use of My Image and that No further compensation is due to me for this release;

*Exclusions(if any):

This release is irrevocable, worldwide and perpetual, and will be governed by the law of Michigan, United States;

I am a legally competent adult over the age of eighteen (18) and have the right to contract in my own name. I have read this document thoroughly and understand the entirety of its contents in and the consequences of such release; and that it shall be binding upon me, my heirs, my legal representatives and my assigns. I warrant that I willingly sign this release without breach of any prior agreements or applicable law including but not limited to prior agreements with modeling or talent agencies or any other person, company or entity.

For the purposes of this document and model release, the following definitions apply:

I, Me, My, model, and model's: persons performing, acting, modeling and posing, on camera who consents to have their image captured.

Photographer: photographer, videographer or artists capturing the model's image.

Image(s): photographs or video footage or illustrations or any derivative work containing a model's likeness, voice, performance and property.

TFP: Time for photos (or trade for pics): instead of charging each other rates or fees, Model exchanges time in return for fully edited photographs from the photographer

Good and Valuable consideration: What the model or gets in return for signing a release/contract. This can be anything of value to the model such as but not limited to, financial compensation, or edited photos, or tangible goods or products such as clothing and food, or other professional services. This is decided between the model and photographer prior to the shoot.

Please read to fully understand your rights and responsibilities as a model for SpyderO Productions

My Legal Rights

1. United States copyright law and specifically copyright act of 1976 states that The Photographer owns the copyright of an image at the moment an image is taken; regardless of TFP, or monetary compensation to myself or the photographer
2. Photographer grants to me limited usage rights for images received from my shoot; which is limited to my personal use, in marketing on my website or social media, and physical prints and copies which I may give out or sell privately. No other use is permitted, commercial or otherwise, unless further rights have been transferred to me by The Photographer on another written agreement.
3. I have no legal right to images taken by the photographer, and thus shall not myself or allow others to alter, edit, crop, or filter images in any way without the express permission of The Photographer. Not only is this illegal but is disrespectful to The Photographer and their artistic vision.
4. Altering, editing, cropping or filtering of images on my part, shall be kept private and not be shared publicly on social media without express permission of The Photographer
5. I have the right to request my real name, personal info, or likeness be removed or kept private at my request (to the extent permitted by law). I understand that while The Photographer will make a best effort to accommodate my request in good faith, signing a model release waives my right of publicity and that once My Image has been published it is impossible to guarantee complete removal due to the nature of online data.
6. I agree to not hold liable The Photographer, for any damages as a result of images containing my likeness being used, published, distributed or marketed.

Agreement for modeling

7. I agree to respect The Photographers time by arriving on set or on the location and time specified (per prior mutual agreement) and to be in costume in makeup, and ready to work either at that time, or by the time The Photographer is ready to begin.
8. I agree to honor my agreement by staying for the entire duration of the shoot and completing all requested shots. In the case of an unforeseen emergency, I may return to complete the shoot at another day and time, at no further cost to The Photographer.
9. I agree to not interfere or allow anyone to interfere with the progress of the shoot either by their presence, conversation, phone call, text, or anything that may cause a distraction to myself or The Photographer during the session. Such interference may result in cancellation of the shoot and forfeiture of compensation or future shoots.
10. I agree to respect the client and/or Photographer's talent and artistic vision by bringing, or wearing any and all requested clothing, shoes, makeup, and/or nail color.
11. I will communicate 24 hours of scheduled shoot time If am unable meet any shoot requirements. Accommodations may be provided to me with advance notice.
12. I agree to respond to communication (emails, calls and texts) from The Photographer within 24 hours of receiving them.
13. I agree to communicate upcoming or recent, significant or permanent changes to my appearance such as hair length and color, visible tattoos, face piercings, or gel manicure pedicure. This also includes unplanned changes such as new bruises, sores, scars, or deformities that were not visible in prior photos or in person.
14. I will **not** intentionally make permanent or significant changes to my appearance after booking and before the shoot, with out prior communication and approval for The Photographer. After the shoot and prior to the next booking I am free to do as I please with my appearance.
15. I will not cancel a booked shoot less than 24hrs from the specified date and time. Cancellation at any time without rescheduling will be considered lack of desire to model and I will not be contacted to model again. Unforeseen circumstances are exempt if timely communication and a reschedule is attempted.
16. I agree that failure to meets these requirements may constitute a breach of contract or verbal agreement and thus frees the photographer from any obligation on their part. This may include cancelation of the shoot, withholding of compensation and fees, and/or forfeiture of future shoots
17. I agree not to hold photographer responsible or any damages incurred from such cancellation or forfeiture as a result of my failure honor these terms.
